Water based products for direct printing on a wide range of fabrics

- opaque, for light and dark backgrounds, featuring high mechanical resistance
- the prints resist washing and dry cleaning after heat curing

PREPARATION : the lacquers are ready for use.

> When printing coarse fabrics, dilution with 5% water is possible. The addition of max 5% white spirit will improve the printability.

Drying can be slowed down by adding max 5% TEXILAC RITARDANTE or 10%

TEXILAC RITARDANTE GEL.

If necessary, the product can be thickened with max 5% TEXILAC ADDENSANTE 162.

COLOURS : see the paragraph PACKINGS in this technical data sheet.

> Special effect can be obtained with metal, pearl, fluorescent or phosphorescent powders to be added to TEXILAC PO TRASPARENTE - TEXILAC PO-E TRASPARENTE - TEXILAC

PO-E SF TRASPARENTE.

PRINTING flat screens: max 70 th/cm rotary screens: max 125 mesh. When printing with powders,

screens and cylinders are chosen according to powders granulometry.

POLYMERIZATION: three minutes at 130° C wash resistance with water

three minutes at 160°C dry cleaning resistance [TEXILAC PO-E SF does not resit to dry

cleaning].

NOTE: Texilac PO-E e Texilac PO-E SF are elastic products. They can be used to print Lycra for swimming clothes and sports-ware polymerising in air dryer at 140° C for 3 minutes.

Over-curing can be cause less elasticity.

CLEANING: wash screens and tools with cold water, immediately after the use.
